Sub:- Compliance to the Judgement dated 20.04.2018 pronounced by the Hon'ble CAT, Calcutta Bench in OA No. 350/533/2018 filed by Sh. Kallol Dutta, SA, O/o GM(F) Kolkata- instructions reg .

Sir/Madam

I am directed to refer on the aforesaid subject and to intimate that an OA No.350/533/2018 has been filed by Shri Kallol Dutta, SA, % GM (F) Kolkatta in the Hon'ble Central Administrative Tribunal, Kolkatta Bench, Kolkatta in respect of notification dated 2.4.2018 pertaining to RR of AAO IP&TAFS Group 'B'. The ibid OA has been decided by the Hon'ble CAT, Kolkatta Bench, Kolkatta with the following directions;

"Let the respondent authorities take a decision on the grievance of the applicant. Accordingly I direct the respondents to consider and dispose of the grievances of the applicant by treating this OA as a representation within a period of 4 months from the date of receipt of the copy of this order. It is made clear that whatever decision be taken that will be reasoned and speaking with opportunity of being heard given to the applicant. The decision so arrived be communicated to the applicant forthwith. Meanwhile the impugned notification dated 2.4.2018 shall not be given effect to till the decision taken by the respondent authorities and communicated to the aggrieved employee i.e. the applicant in the present OA."

Accordingly, till the time the ibid orders of the Hon'ble CAT are complied with by the respondent authorities notifications, in respect of AAO of IP&TAFS Group 'B', dated 2nd April, 4th April and 19th April 2018 may not be given effect.
