Sub: Competitive Examination for recruitment to the cadre of Postman and Mail Guard from eligible MTS and GDS for the vacancy year 2018 & 2019 (01.04.2018 to 31.12.2018 & 01.01.2019 to 31.12.19).

The Limited Departmental Competitive Examination (LDCE) limited to MTS officials and Competitive Examination limited to GDSs will be held on **29th of September, 2019** (Sunday) for recruitment to the cadre of Postman and Mail Guard for the vacancy year 2018 (01.04.2018 to 31.12.2018) & 2019 (01.01.2019 to 31.12.2019). Accordingly, applications are invited from the willing and eligible candidates in the format enclosed (**Annexure-I**). The schedule of activities of the examination is furnished hereunder:

*Exam will commence at 10:00 AM sharp in the Circle and both the Paper-I & II will be conducted in continuity in one sitting from 1000hrs to 1235 hrs. There will be 5 minute's break in between Paper-I and Paper-II, but, candidates cannot be allowed to leave his/her desk.

2. **Vacancies:** Number of vacancies available under Recruiting Division / Unit – wise is furnished in enclosed Annexure A, B, C & D for vacancy year 2018 & 2019.

Note:

Unfilled vacancies of Seniority Quota (DPC) will be added to the number of vacancies of that particular Division/Unit as per reports received from the Regions as per Rectt. Rules.

3. **Eligibility Criteria:** - As per the Department of Posts Postman and Mail Guard (Group 'C' post) Recruitment Rules, 2018 notified in GSR 899 (E) dated 20.09.2018, the following categories of official (s) are eligible to appear in the examination:

- (i) Multi Tasking Staff (MTS) in Level -1 of the pay matrix with three years regular service in the grade as on the **01.04.2018 & 01.01.2019 respectively for the year 2018 & 2019.**
- (ii) Gramin Dak Sevaks (GDSs) who have worked regularly for five years in that capacity as on the **01.04.2018 & 01.01.2019** and fulfilling the following conditions for the year 2018 & 2019 respectively:

(a) **Educational Qualification:** 10th standard pass from a recognized Board.

(b) **Age:** Maximum age as on 01.04.2018 & 01.01.2019 for UR candidates shall be 50 years, for SC/ST will be 55 and for OBC is 53 for the year 2018 & 2019 respectively.

(c) The candidate should have studied local language at least upto 10th standard, i.e. Marathi for Maharashtra State and Konkani for Goa State. (As notified by SPN Division of the Directorate vide Annexure- E of letter No. 17-08/2018-SPB-I dated 10.05.2019, 28.06.2019, 11.07.2019 & 23.07.2019 circulated vide CO Mumbai vide No. Rectt/1-1/ORD/2011/I dated 14.05.2019, 11.07.2019 and 31.07.2019 respectively.)

(d) Knowledge of working on Computer.

(e) Candidate should have a valid license of two-wheeler or light motor vehicle. Persons with Disability are exempted from the possession of licence. However, GDS without license to drive two wheeler or light motor vehicle shall also be allowed to appear in the examination.

[This condition is required for recruitment to the cadre of Postman only]

Note:

- (i) Candidate belonging to postal division shall clearly indicate order of preference in Application form for postal divisions excluding parent division followed by RMS divisions.
- (ii) Candidate belonging to RMS division shall clearly indicate order of preference in Application form for RMS divisions excluding parent division followed by Postal divisions.

(iii) Candidate must exercise preference for all Recruiting Units for consideration in the Proforma at **Annexure-II**.

(iv) Order of preference (as per **Annexure-II**) once exercised shall not be changed.

4. **Pattern & Syllabus of Examination:** The examination will be conducted as per the revised pattern and syllabus circulated by Directorate vide letter No. 17-08/2018-SPB-I dated 10.05.2019 under Annexure –‘B’ read with letter No. 17-08/2018-SPB-I dated 20.06.2019, 26.06.2019, 28.06.2019 & 11.07.2019 & 23.07.2019. Details of Pattern and Syllabus are furnished in **Annexure-III**.


Paper-III i.e. ‘Skill test of data entry’ will be conducted subsequently

5. **Centres of Examination:** The examination will be conducted at all Regional Headquarters only. The candidates shall have to appear from the respective centers of their Region only and under no circumstances, they be permitted to appear from other Regional Centers.

6. The application of the APS candidates should be sent to the concerned Divisions only and not to Circle office.

7. This notification may be given wide publicity amongst all eligible candidates working in Divisions/Units.
