Subject : Conducting of Limited Competitive Examination from Gramin Dak Sevak (GDSs) for recruitment to the cadre of Postal Assistants/Sorting Assistants for the vacancy years 2014, 2015-16, 2016-17, 2017-18, 2018(01.04.2018 to 31.12.2018) & 2019 (01.01.2019 to 31.12.2019).

The Limited Competitive Examination will be held on 15<sup>th</sup> of September, 2019(Sunday) for recruitment of Postal Assistants/Sorting Assistants from Gramin Dak Sevaks(GDSs) for unfilled vacancies of LDCE for promotion from Postman/ Mail Guard and MTS to the cadre of Postal Assistants/Sorting Assistants for the vacancy years 2014, 2015-16, 2016-17, 2017-18, 2018(01.04.2018 to 31.12.2018) & 2019(01.01.2019 to 31.12.2019). \* Exam will commence exactly at 10:00 AM in all the Regions and both Paper I & II will be conducted continuously from 10:00 AM.

2. **Vacancies:** Number of vacancies available under Recruiting Division/Unit – wise is furnished in Annexure – II(A to E) . Vacancies for the Recruitment Year 2019 to be published after declaration of results of the LDCE for recruitment to the cadre of PA/SA for the vacancy year 2019(01.01.2019 to 31.12.2019) from Postman/Mail Guard, Despatch Rider and MTS.

3. **Eligibility Criteria:** - As per the Recruitment Rules notified in GSR 411(E) dated 21.05.2015 circulated by this office letter no. Rectt/1-1/ORD/2011/I dated 23.06.2015, the following conditions are to be fulfilled:

- i. **Educational Qualification:** 10+2 standard or 12<sup>th</sup> class pass from a recognized University/Board
- ii. **Age:** Should be within 30 years of age (relaxable for different categories as notified by the Government of India from time to time)
- iii. **Service eligibility:** Must have put in a minimum service of five years as on the 1<sup>st</sup> day of April/1<sup>st</sup> Jan (As shown in Annexure IV) of the year to which the vacancy (vacancies) pertains to.
- iv. The Eligibility criteria will be determined as on 1<sup>st</sup> April/Jan of the year to which vacancy pertains to i.e. 01.01.2014, 01.04.2015, 01.04.2016, 01.04.2017, 01.04.2018 & 01.01.2019.

4. **Pattern & Syllabus of Examination:** The examination will be conducted as per the revised pattern & Syllabus circulated by Directorate vide letter no. 17-08/2018-SPB-I dated 10.05.2019 under Annexure C circulated by this office letter no. Rectt/1-1/ORD/2011/I dated 14.05.2019 which shall be read with Directorate letter no. 17-08/2018-SPB-I dated 20.06.2019, 26.06.2019, 11.07.2019 & 23.07.2019 circulated by this office letter no. Rectt/1-1/ORD/2011/I dated 26.06.2019, 11.07.2019 & 31.07.2019 and are enclosed as Annexure -III.
