In view of Judgment Order of Hon'ble Supreme Court and approval of Directorate for implementation of the Judgment, a Committee was constituted to work out strategy for segregation of the candidates as tainted and non-tainted.

Accordingly, list of suspicious tainted candidates was published on 29.01.2021 vide letter referred above. In the said list, total 73 candidates were declared as suspicious tainted whose signature variation was found. These candidates were called to this office on 19.02.2021 for submission of Specimen Signature for onward submission to CFSL. The candidates who failed to attend this office on 19.02.2021 were again requested to attend this office for providing specimen signature on 06.04.2021, intimating that failure to attend this office will be presumed that the candidates are not interested for providing specimen signature and will concluded that someone impersonated the candidate during the exam and their candidature will be treated as tainted.

Accordingly, 3 candidates submitted their unwillingness to join the Department. Hence, their candidature is cancelled.


The list of these 3 candidates is attached herewith at Sl. No. (I) of Annexure.

Remaining 10 candidates neither attended this office to provide specimen signatures on 19.02.2021 and 06.04.2021 nor submitted any representation till date. Hence, these 10 candidates are hereby declared as Tainted candidates and their candidature has been cancelled.
